Enrollment: The Parent/Guardian undertakes to enroll the Player in Deutsche Football Academy to participate in football training sessions and associated activities. Consent and Authorization:

The Parent/Guardian hereby grants consent and authorization to the Academy to train, coach, and oversee the Player during their involvement in the Academy's programs.

This authorization encompasses, but is not limited to, providing a Training Plan, facilitating the Development of Technical Skills, and participating in tournaments or events organized by the Academy. The Academy shall undertake the responsibility of meticulously preparing the player, enhancing their skills, and fostering their talent to meet the standards required by the premier clubs in Europe.

This includes but is not limited to: Comprehensive Training: The Academy will provide intensive training sessions aimed at refining the player's technical abilities, tactical awareness, physical fitness, and mental resilience. Individualized Coaching: Our experienced coaches will offer personalized guidance and mentorship to the player, addressing their specific strengths and areas for improvement.

Exposure Opportunities: The Academy will actively seek opportunities to showcase the player's talents to renowned clubs in Europe through participation in tournaments, showcases, and scouting events. Professional Representation: We shall liaise with reputable sports agents and intermediaries to represent the player's interests and negotiate potential contracts with European clubs.

Ongoing Support: Throughout the process, the Academy will offer continuous support and guidance to the player and their family, ensuring transparency, clarity, and professionalism at every stage of their journey towards securing a placement with a prestigious European club. The player and their parents/guardians acknowledge and agree to the above terms, understanding that the ultimate goal is to facilitate the player's advancement to the highest levels of professional football in Europe."

Financial Obligation: The Parent/Guardian agrees to fulfill the necessary fees and charges associated with the Player's enrollment in the Academy.

These fees may encompass registration fees, monthly subscription fees, and any additional costs for specialized training programs or events.

Monthly Fee Structure: Outlined below is an overview of our monthly fees categorized by age groups:

After signing the contract, each player will receive a training kit, two jerseys, two shorts, and four socks free of charge. Any additional training kits required will incur extra costs.

Additional Expenses: In addition to the monthly fees, please take note of potential extra payments for: **Travel Expenses:** Participants may need to cover transportation costs for training sessions, away games, tournaments, or events with clubs like Ajax Amsterdam, Liverpool, and Arsenal.

Specialized Training Programs: Fees may apply for specialized training sessions, such as goalkeeper training or speed and agility programs.

Individual Coaching: Private coaching sessions beyond regular team practices may incur extra costs. **Additional Training kits** include jerseys, shorts, and socks for optimal performance during practice sessions and matching jerseys, training jackets and pants, tracksuits, and training shoes.

Please be informed that these fees are subject to change based on the academy's policies and program offerings. Our partners and sponsorships are committed to covering some additional expenses incurred by players who may not have sufficient financial resources

Commitment to Attendance and Conduct:

The Parent/Guardian commits to ensuring the Player's consistent attendance at training sessions and Academy events. Furthermore, the Parent/Guardian agrees to uphold good sportsmanship and conduct from the Player, both on and off the field, in compliance with the Academy's rules and regulations. Deutsche Football Academy rules

- **Code of Conduct:** Clear guidelines outlining expected behavior both on and off the field, including respect for coaches, teammates, opponents, and officials.
- **Attendance:** Expectation for regular attendance at training sessions, matches, and other academy events, with consequences for unexcused absences.
- **Punctuality:** Importance of arriving on time for training sessions and matches to ensure effective use of time and respect for teammates and coaches
- **Equipment:** Requirement for appropriate sports attire and equipment during training and matches, including football boots, shin guards, and water bottles.
- **Discipline:** Consequences for disciplinary infractions, such as disruptive behavior, disobedience, or unsportsmanlike conduct, with measures for addressing and resolving conflicts.
- **Safety:** Emphasis on player safety, including adherence to safety protocols during training and matches, awareness of potential risks, and procedures for injury prevention and management.
- **Academic Commitment:** Recognition of the importance of academic success alongside athletic development, encouraging players to maintain a balance between their studies and football commitments.

- Respect for Facilities: Expectation for maintaining cleanliness and respect for academy facilities, equipment, and property.
- Anti-Discrimination: Zero-tolerance policy towards discrimination or harassment based on factors such as race, ethnicity, gender, religion, or sexual orientation.
- Communication: Channels for effective communication between players, parents, coaches, and academy management, including feedback mechanisms and avenues for addressing concerns or grievances.
- Confidentiality: Respect for the privacy and confidentiality of academy-related matters, including player information and internal discussions.
- Commitment to Improvement: Encouragement for players to strive for continuous improvement, setting goals, and working diligently towards achieving personal and team objectives.

Acknowledgment of Risks:

The Parent/Guardian acknowledges and comprehends that participation in football activities carries inherent risks of injury. The Parent/Guardian agrees to assume all associated risks with the Player's involvement in the Academy's programs and indemnifies the Academy from any liability for injuries incurred during such participation, except where attributable to the Academy's negligence.

Termination of Agreement:

Either party reserves the right to terminate this Agreement upon written notice to the other party, with a notice period of six months. In case of termination, any fees or charges previously remitted to the Academy shall be non-refundable unless otherwise stipulated in writing by the Academy. Privacy Policy: Deutsche Football Academy is committed to protecting the personal information of players and their parents/guardians in accordance with relevant data protection laws. The information collected will be used solely for internal purposes of the Academy and will not be shared with third parties unless required by law or necessary to fulfill the purposes outlined in this contract.

Players and parents/guardians have the right to access, correct, or delete their personal data by contacting Deutsche Football Academy.

By signing this contract, parents/guardians agree that Deutsche Football Academy processes personal data in accordance with this Privacy Policy, and stores the information provided for membership administration and internal club purposes, as well as for sharing with other clubs or agents who may be interested in the players.

Additionally, parents/guardians consent to the use of provided photographs by the club itself and the German Football Association (DFB).

The player and parent/guardian also agree that Deutsche Football Academy may send information about the player, including photos and videos, to other clubs or agents, as well as to print and online media.
